2.	<input type="checkbox"/>	The Travel Document Should be valid for at least 6 months (recommended 09 months) Passport must have at least 2 blank pages.
3.	<input type="checkbox"/>	MUST submit ALL <b>PASSPORTS</b> that you hold (including current/ old/ cancelled/ expired/ special).
4.	<input type="checkbox"/>	a) Approval Letter from the place of work for your travel. If you are an employee in a company, please provide a valid official letter from your employer in English with position in company and salary.
	<input type="checkbox"/>	b) If the applicant owns a company, please provide a registration certificate of the company from your country's authorities, in which your name appears as the owner.
	<input type="checkbox"/>	c) Last three months of bank statement, in which the name of the applicant appears clearly. With original bank stamp if the applicant has a business account, please also attach copy of that account (for last 3 months).
	<input type="checkbox"/>	d) For students, Student ID is required.
5.	<input type="checkbox"/>	Proof of property or rent contract and electronic or water bills is required.
6.	<input type="checkbox"/>	Family Book
7.	<input type="checkbox"/>	Children under the age of 18 years must to have parent's permission from the police (original), and birth certificate.
8.	<input type="checkbox"/>	In case of Divorce, child custody or letter from court in respect of the child required.
9.	<input type="checkbox"/>	Vaccination Card.
10.	<input type="checkbox"/>	Health insurance (Covered covid-19).
11.	<input type="checkbox"/>	Must enclose the following documents: <b>1. Visiting Relative or Friends:</b>
	<input type="checkbox"/>	a) If invited by a friend / relative in Israel attach invitation letter with contact details of the invitee (Place of residence in Israel, full address and phone number) & Israeli inviter ID copy.
	<input type="checkbox"/>	<b>2. Tourist Visit :</b>
	<input type="checkbox"/>	a) A hotel reservation in Israel, including the hotel's name, the city, phone number and number of reservation.

## **IMPORTANT REMARKS**

1. IN CASE OF MINOR ACCOMPANYING PARENTS: -

a) Children under the age of 18 years must have parent's permission (no-objection) from the Police (original) & Birth Certificate.

b) In case one of the parents is not in country then he/ she should go to the Embassy of UAE in the foreign country to issue no- objection for travel.

2. Embassy may ask for additional documents or request for personal appearance at the Embassy.
